### **CALL FOR APPLICATIONS**

1. for election (advancement) of one senior assistant into lecturer in a research-teaching position and corresponding employment position of assistant professor (vacant position in lieu of M.M.), in the scientific area of Social Sciences, the field of Pedagogy, the branch of Special Pedagogies, in the Department of Pedagogy,
2. for election of one associate into an associate position and corresponding employment position of assistant, for a limited period of time (temporarily vacant position) in the scientific area of Social Sciences, the field of Pedagogy, the branch of General Pedagogy, in the Department of Pedagogy,
3. for election of one associate into an associate position of nominal assistant or postdoctoral fellow, for a limited period of time, in the scientific area of Social Sciences, the field of Pedagogy, the branch of General Pedagogy, in the Department of Pedagogy,
4. for election of one associate into an associate position of nominal assistant, for a limited period of time, in the scientific area of Social Sciences, the field of Information and Communication Sciences, the branch of Information Systems and Informatology, in the Department of Information Sciences,

9. for election of one lecturer into the same teaching position and corresponding employment position of senior instructor, in the scientific area of the Humanities, the field of Philology, the branch of English Studies (the English language), in the Centre for Foreign Languages,
10. for election of one lecturer into a teaching position of nominal instructor or senior instructor, in the scientific area of the Humanities, the field of Philology, the branch of Romance Studies (the Portuguese language), in the Department of French and Ibero-Romance Studies,
11. for election of one lecturer into a teaching position of nominal instructor or senior instructor, in the scientific area of the Humanities, the field of Philology, the branch of Japanese Studies (the Japanese language), in the Centre for Foreign Languages,
12. for election of one associate into an associate position and corresponding employment position of assistant, for a limited period of time (until a lecturer returns from maternity leave), in the scientific area of the Humanities, the field of Philology, the branch of English Studies (the English language), in the Centre for Foreign Languages,
13. for election of one lecturer into a teaching position of nominal instructor, in the scientific area of the Humanities, the field of Theology, the branch of Moral Theology, in the Department of Theology and Catechism,

Applicants are expected to meet the requirements of the Labour Act (Official Gazette, no. 93/14), the requirements of the Science and Higher Education Act (Official Gazette, nos. 123/03, 198/03, 105/04, 174/04, 2/07 – Decree of the Constitutional Court of the Republic of Croatia, 46/07, 45/09, 63/11, 94/13, 139/13, and 101/14 - Decree of the Constitutional Court of the Republic of Croatia) and the regulations based therein, as well as the requirements stipulated by other acts.

In addition to general requirements, applicants for the teaching position of nominal instructor or senior instructor for the research area of the Humanities, the field of Philology, the branch of Romance Studies (the Portuguese language), in the Division of Ibero-Romance Studies of the Department of French and Ibero-Romance Studies, are expected to hold a corresponding graduate or Master's university degree, to have been previously elected by the Camões Institute, and are expected to meet the requirements of the Rectors' Conference for the election into the teaching position of instructor or senior instructor.

Gender-related expressions used in this call for applications are used neutrally and refer to both feminine and masculine gender.

Two copies of the following documents should be attached to the letter of application:

- curriculum vitae (for all positions),
- diploma or degree certificate (for the professional title, academic title or academic degree) which may be used as a proof of meeting the requirements for election into a particular position (for all positions),
- certificate of Croatian or other citizenship (for all positions),
- certificate of fluency in Croatian (for foreign citizens),

- copy of a decision of election into a research position, if election to corresponding position has already been completed; or books, research papers and other papers relevant for the election into a research position (for research-teaching positions),
- list of books, research papers and other papers, grouped into two sections: up to the most recent election or re-election, classified according to paper categories, and after the most recent election or re-election, classified according to paper categories (for research-teaching positions),
- report on research-teaching activities (for research-teaching positions),
- papers (research, professional, review, etc.) and their list grouped into two sections: papers published until the most recent election or re-election, classified into categories, and new papers published after the most recent election or re-election, classified into categories (for teaching positions),
- report on teaching activities (for teaching positions),
- evidence of election by the Camões Institute (for the teaching position of nominal instructor or senior instructor for the area of the Humanities, the field of Philology, the branch of Romance Studies (the Portuguese language), in the Division of Ibero-Romance Studies of the Department of French and Ibero-Romance Studies),
- official transcript with the grade point average for the previous studies (without the graduate diploma paper grade) or the study diploma supplement confirming the exams passed and grades obtained, including the information on study workload and the subjects taken (for the associate position of an assistant),
- evidence that the applicant graduated as one of the 10% of the best students of the generation, or as one of the 10 best graduates, if fewer than 100 students graduated from the same study (for the associate position of an assistant),
- evidence of positive results obtained by the institutional evaluation of the applicant's teaching performance, or evidence of positive results obtained by student evaluation at an institution of higher education (for applicants in the process of being elected into the same or higher position, as well as for applicants who have previously taught classes at institutions of higher education).

Letter of application, curriculum vitae, report on the research-teaching activities, report on teaching activities, abstracts and lists of papers should also be submitted in an electronic form (on a CD), in PDF format, in two copies.

Deadline for application is 30 days from the date of publication of the call for applications in the Official Gazette.

Late and incomplete applications shall not be taken into consideration.

Election process will be completed within the legally bound period and the applicants will be notified of the results within 15 days from the completion of the election process.
