CALL FOR APPLICATIONS

1. for election (advancement) of one lecturer from the research-teaching position and corresponding employment position of tenured full professor (in lieu of P. Ž.) in the scientific area of Humanities, the field of History, the branch of Croatian and World Mediaeval History, in the Department of History,
2. for election of one lecturer into a research-teaching position and corresponding employment position of assistant professor (in lieu of S. B. D.) in the scientific area of Humanities, the field of History, the branch of Croatian and World Modern and Contemporary History, in the Department of History
3. for election of one associate into an associate position and corresponding employment position of assistant, for a limited period of time, full-time (in lieu of P. Ž.), in the scientific area of Humanities, the field of History, the branch of Croatian and World Modern and Contemporary History, in the Department of History
4. for election of one lecturer into a teaching position of nominal lecturer in the scientific area of Humanities, the scientific field of Theology and the branch of Exegesis, in the Department of Theology and Catechism
5. for election of one lecturer into a teaching position of nominal lecturer in the scientific area of Humanities, the scientific field of Theology and the branch of Liturgics, in the Department of Theology and Catechism
6. for election of one associate into an associate position of nominal assistant in the scientific area of Humanities, the scientific field of Theology and the branch of Ecclesiastic History, in the Department of Theology and Catechism
7. for election of one associate into an associate position of nominal assistant in the scientific area of Humanities, the scientific field of Science of Religion (an interdisciplinary field), in the Department of Theology and Catechism
8. for election of one associate into an associate position of nominal assistant, for a limited period of time, in the scientific area of Engineering, the scientific field of Mechanical Engineering, the branch of Production Engineering, in the Department of Ecology, Agronomy and Aquaculture
9. for election of one lecturer into a research teaching position of a nominal assistant, associate or full professor in the scientific area of Natural Sciences, the field of Interdisciplinary Natural Sciences, the branch of Maritime Science, in the Department of Ecology, Agronomy and Aquaculture
10. for election of one lecturer into a research-teaching position and corresponding employment position of full professor or tenured full professor, 50% of full-time employment, in the scientific area of Biomedicine and Health Sciences, the field of Clinical Medical Science, the branch of Paediatrics, in the Department of Health Studies

11. for election of one lecturer into a research-teaching position and corresponding employment position of assistant professor, 50% time, in the scientific area of Biomedicine and Health Sciences, the field of Primary Medical Science, the branch of Anatomy, in the Department of Health Studies,
12. for election of one lecturer into a research-teaching position and corresponding employment position of assistant professor, 20% time, in the scientific area of Biomedicine and Health Sciences, the field of Clinical Medical Science, the branch of Internal Medicine, in the Department of Health Studies.

Applicants are expected to meet the requirements of the Labour Act (Official Gazette, no. 93/14), the requirements of the Science and Higher Education Act (Official Gazette, nos. 123/03, 198/03, 105/04, 174/04, 2/07 – Decree of the Constitutional Court of the Republic of Croatia, 46/07, 45/09, 63/11, 94/13, 139/13, and 101/14 - Decree of the Constitutional Court of the Republic of Croatia) and the regulations based therein, as well as the requirements stipulated by other acts.

Gender-related expressions used in this call for applications are used neutrally and refer to both feminine and masculine gender.

Applications should be submitted to the University of Zadar / Sveučilište u Zadru, HR-23000 Zadar, M. Pavlinovića 1.

Two copies of the following documents should be attached to the letter of application:

- curriculum vitae (for all positions),
- diploma or degree certificate (for the professional title, academic title or academic degree) which may be used as a proof of meeting the requirements for election into a particular position (for all positions),
- certificate of Croatian or other citizenship (for all positions),
- certificate of fluency in Croatian (for foreign citizens),
- copy of a decision of election into a research position, if election to corresponding position has already been completed; or books, research papers and other papers relevant for the election into a research position (for research-teaching positions),
- evidence of a previous election into a research-teaching, teaching or associate position (for applicants who have so far been elected into research-teaching, teaching or associate positions),
- list of books, research papers and other papers, grouped into two sections: up to the most recent election or re-election, classified according to paper categories, and after the most recent election or re-election, classified according to paper categories (for research-teaching positions),
- report on research-teaching activities (for research-teaching positions),
- papers (scientific, expert, reviews,...), and their list divided in two groups: papers published up to the last election or re-election, sorted into categories, and new papers published afterwards, sorted into categories (for teaching positions)
- report on teaching activities (for teaching positions),
- official transcript of records with the grade point average for the previous studies (without the graduate diploma paper grade) or the study diploma supplement confirming the exams passed and grades obtained, including the information on study workload and the subjects taken (for the associate position of an assistant),
- evidence that the applicant graduated as one of the 10% of the best students of the generation, or as one of the 10 best graduates, if fewer than 100 students graduated from the same study (for the associate position of an assistant),
- evidence of positive results obtained by the institutional evaluation of the applicant's teaching performance, or evidence of positive results obtained by student evaluation at an institution of higher education (for applicants in the process of being elected into the same or higher position).

Letter of application, curriculum vitae, report on the research-teaching activities, report on teaching activities, abstracts and lists of papers should also be submitted in an electronic form (on a CD), in PDF format, in two copies.

Deadline for application is 30 days from the date of publication of the call for applications in the Official Gazette.

Late and incomplete applications shall not be taken into consideration.

Election process will be completed within the legally bound period and the applicants will be notified of the results within 15 days from the completion of the election process.
