Course subject	The basic goal of the course is to introduce students to the basic concepts and theoretical frameworks of pragmatics within which language and language use are interpreted from the viewpoint of human behaviour. Thus, the aims of the course include developing students' critical thinking towards relevant theoretical frameworks and methodological procedures from the viewpoint of speech acts and other forms, principles and consequences of communication interaction. Special attention is paid to similarities and differences between relevant areas of pragmatic investigation and other related linguistic disciplines, primarily syntax, semantics and sociolinguistics. This allows for a clearer insight into the interrelatedness of language structure, meaning dimension and extralinguistic factors that contribute to successful communication. Students are required to write a seminar paper in the field of pragmatics, 2500-3000 words in length. Students should propose the topic of the paper (during office hours or via e-mail), find and read the relevant literature for writing the seminar paper. The aim of the seminar paper is the acquisition of basic skills necessary to write seminar papers. Students should follow the MLA referencing style throughout the paper. The first version of the paper should be sent by the beginning of the 13th week of class.
